

# Georgia Erosion & Sediment Control Training & Certification Program

Georgia's **Erosion & Sediment Control (E&SC) training and certification program** is upon us and the **Georgia Association of Water Professionals (GAWP)** has course schedules to satisfy the needs of nearly *30,000* professionals who require this new certification.

The *Georgia Erosion & Sedimentation Act* states that **all persons** involved in land disturbing activities must be trained and state certified by **December 31, 2006**, however, the state has approved 2007 courses and encourages all who need this certification to register and attend a course as soon as possible. Depending on your level of involvement in the land disturbing process, several of your employees will probably need to attend one or more of the following courses and successfully pass a formal exit examination:

**Level 1A** - Developers, Builders, Contractors, Monitoring Consultants, City/County  
Construction  
\$150

**Level 1B** – Regulatory Inspectors  
\$225 Members / \$255 Non-Members

**Level 2** – Plan Designers and Plan Reviewers  
\$295 Members / \$325 Non-Members
